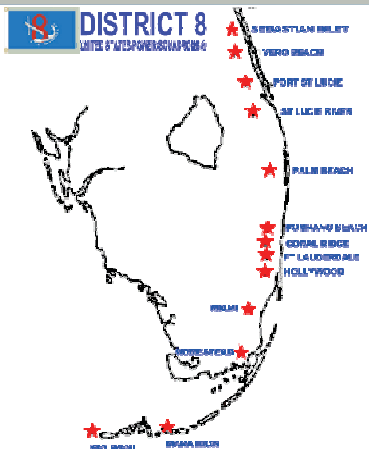

An absent squadron commander may be represented by another bridge officer of the squadron and in the absence of an officer for whom there is an elected assistant, the assistant may act for the principal.

- Reports of district department chairmen.
- Reports of General Committees.
- Reports of Standing Committees.
- Announcements.
- Other business that may properly come before the Council.

CALL TO THE FALL CONFERENCE

In accordance with the provisions of Article 5 of District 8 Bylaws, District Commander Allan B. Furtado, SN issues the Call to the Fall Conference. It is to be held at the Embassy Suites Hotel, 4350 PGA Blvd, Palm Beach Gardens, FL 33410, Saturday, 24 September 2016 at 1400.

The purpose of the meeting is to act on matters set forth below.

1. To hear and act upon reports of officers.
2. To consider and act upon any other business that may properly come before the Conference.
3. To consider and act upon reports, resolutions and recommendations from the Council, officers and committees.

District 8 Bylaws Article 4 and 5 describe the Conference and its functions extensively and are recommended reading for all members.

Section 4.1: The Conference shall be composed of the Council, the past district commanders of this district who are active members of district squadrons, and the delegates which persons shall be the voting members of the Conference.

Section 4.2.1: Delegates shall be selected by each squadron on the basis of one delegate for each twenty five (25) active members in good standing or major fraction thereof as of the preceding 1 March, with a minimum of two (2) delegates per squadron.

Section 4.2.3: Prior to each meeting of the Conference each squadron commander shall submit in writing to the district secretary, a list of the squadron's delegates entitled to vote at the Conference. PLEASE BE ADVISED THAT DELEGATES MAY VOTE ONLY IF NAMES HAVE BEEN SUBMITTED TO SECRETARY PRIOR TO MEETING.

Section 4.2.4: If a delegate is disqualified or unable to attend, the squadron commander may appoint a substitute and notify the secretary prior to the convening of the meeting.

It's that time of year again ... countdown for us to year end totals and deadlines. So, here goes.

- 5** The minimum number of Vessel Safety Checks a Vessel Examiner has to perform and enter online annually to maintain their certification.
- 10** The minimum number of Vessel Safety Checks, as outlined by the United States Power Squadrons® Safety Committee policy statement, for a current Vessel Examiner to achieve a Merit Mark. A new Vessel Examiner qualifies to receive a Merit Mark after finishing their training, passing the VSC exam and completing 5 initial supervised VSCs.
- 20** The minimum number of Vessel Safety Checks necessary to achieve an annual District 8 VSC Individual Achievement Award.
- 100** The minimum number of Vessel Safety Checks needed to be a USPS Annual Century Club member.
- 1,000** The minimum cumulative number of Vessel Safety Checks, usually attained over a period of years, to be a member of the USPS Millennium Club.
- 23 Sept** Margie's birthday.
- 30 Nov** Deadline to have posted all Vessel Safety Checks online to be eligible for USPS Safety Committee awards for top 5 squadrons, top 5 districts and all individual awards.
- 31 Dec** Deadline to have posted all Vessel Safety Checks online to be eligible for all District 8 individual and squadron VSC awards. And, deadline for all annual VSC postings to be reported from USPS to USCG.

We know it's not solely about the numbers. It's about safe boats and safe and knowledgeable boaters. But Merit Marks and awards recognize and thank all of us who have spent many hours, in good weather and sometimes not so good weather, standing on the docks in the marinas introducing the United States Power Squadrons to hundreds of boat owners, providing the public service of a Vessel Safety Check and guiding boaters to register on our website for USPS membership and courses.

Please be watchful of the deadlines and don't be left out due to an administrative error of omission.

And, thanks to all of you.

ENVIRONMENTAL REPORT

Environmental challenges continue but some are working to help improve these conditions. Here is an excerpt from the Vero Beach Power Squadron Nautical News for your information. This input comes from - Save The Lagoon Committee - Toby Jarman, S.

Vero Beach Power Squadron continues to partner with other great organizations to promote increases in the Indian River Lagoon's water quality and wildlife populations. The latest example is the placement of over 1,000 oyster mats in the Lagoon just north of Grand Harbor's Loggerhead Marina. VBPS members David Hornchek and Toby Jarman used their boats to transport the mats and supplies to the placement site. These mats will "catch" oyster larvae from nearby oyster beds thus expanding the oyster population in the area. This is important because each new oyster will clean and clarify up to 55 gallons of water each day.

DISTRICT 8 SQUADRONS VOLUNTEER FOR THE 9TH ANNUAL TREASURE COAST WATERWAY CLEANUP

This cleanup covers 125 miles of waters in Martin, St Lucie and Indian River Counties. Since 2008, they have removed 2,200 boats and more than 67 tons of trash from the waters.



The waterways accumulate trash and debris from many sources. The cleanup effort this group does is important not only for the health of the waterways because of the removal of the debris, but also it brings together the users of the waterway and fosters a sense of community and environmental awareness.

Every boater loves enjoying our waterways and each of us had a chance to keep those waterways clean and healthy for future generations.

St. Lucie River Power Squadron, Port St Lucie Power Squadron, Vero Beach Power Squadron and Sebastian Inlet Sail & Power Squadron along with 1000 plus volunteers work together to keep our waterways clean. They volunteer with the Treasure Coast Waterway summer cleanup effort conducted by Marine Industries Association of the Treasure Coast (MIATC) and sponsored by the Florida Inland Navigation District.

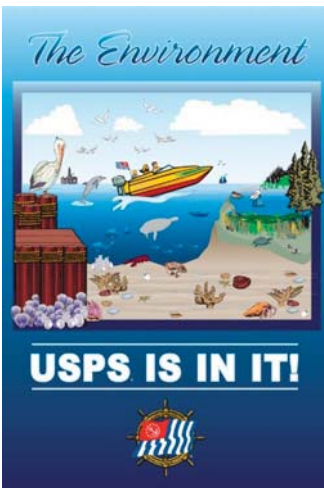
USPS is proud of their Squadrons. They have adopted shoreline and beach areas for year 'round cleanup and have been instrumental in educating the public in the value of this undertaking.

EDUCATION NEWS

I hope everybody is having an excellent summer by doing some boating and also planning for the Fall Courses? Remember to input all Courses and Seminars in the 800 system. The D8 Educational program is going great!! Lets keep it up this coming year.

In the last year USPS has taught the ABC Course to 8,005 students in 743 classes. We had 258 squadrons teach one or more sessions. 38 squadrons taught more than 50% of the students. In District 8, we have 5 squadrons in that group – Hollywood 129 students, Palm Beach 124, Key West 99, Vero Beach 80 and Ft Lauderdale 52.

In Advanced grades and Elective courses USPS has taught 821 students with 253 squadrons. 43 squadrons taught 50% or more of the students. District 8 had 2 squadrons in that group – Palm Beach taught 36 students and Pompano Beach 32 students.

We did not place in the top 50% in teaching Seminars. 84 squadrons taught 2,281 students. 11 squadrons did more than 50%. This is the area we need to focus on this year. Think about how your squadron can start a seminar program. We will talk more about it at the Fall Conference Educational Meeting.

D8 will be the first district to teach the new AIS (Automatic Identification System) Marine Radio seminar. This will be a beta test. The seminar will be FREE this time only. We will need to provide feedback to the Course Committee.

The seminar will start at 0830 Saturday, 24 September 2016 at the Fall Conference. The course will tell us what forms it comes in, how it interacts with your other electronic navigation equipment, what it does, how it works, how to use it, and why we might need it. It will be taught by a member who is an excellent instructor and has used AIS, Cdr Richard Wood, JN.

Everybody who will teach or uses electronic navigation equipment should attend. That means we should have one or more members from each squadron.

Starting 1 December 2016, National will charge an additional \$20.00 fee for all nonmembers taking a course. When pricing the courses after that date remember that charge will be applied to your squadron. This fee is to help offset the cost of maintaining the data base for the over 11,000 people who have taken a course and not joined. This is another tool to help your squadron to get members. We will go into more detail about this at the Fall Conference.

I am looking forward to seeing you at the Fall Conference.

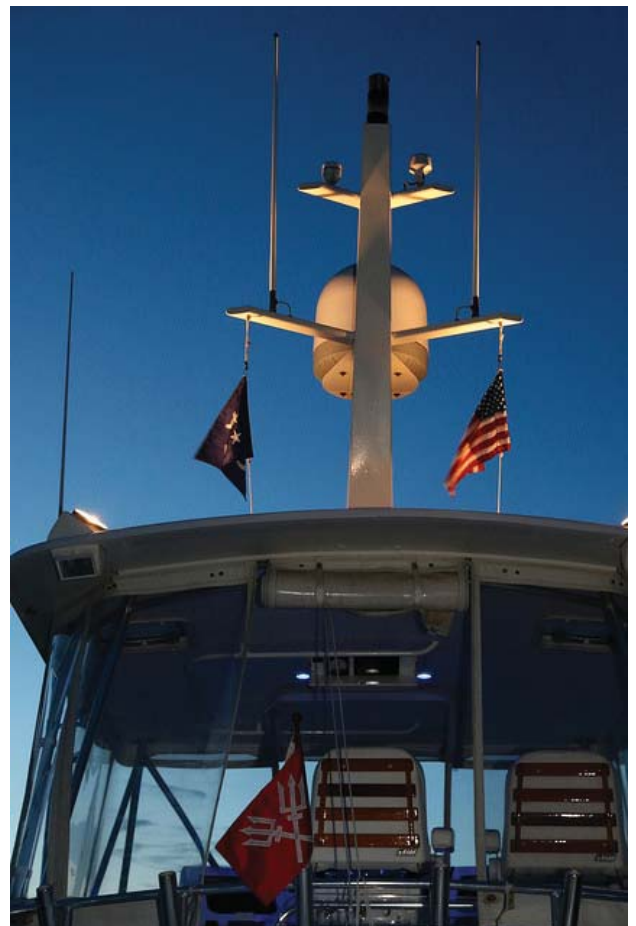
